The POWER project is aimed at contributing, supporting, and building the capacity of civil society organizations active at local, regional, national, and European levels in the **fight against gender-based violence** thus contributing to the plenary guaranty of women's rights, to the equal empowerment of women and men, in all their diversity.

The specific objective of the POWER project is to **improve the impact of Italian, Spanish and Greek NGOs in the fight against gender-based violence**, promote gender equality and the empowerment of women at local, regional, national and European level.

## IMPACT

- **45 NGOs** will be supported through financial funding
- **60 professionals** from these organisations will receive training on European projection
- **750 people** will benefit from the services provided by the selected projects
- **270 professionals/interested parties** will be informed/trained
- **45 institutions** will be involved throughout the European territory

# POWER

## RESULTS AND MAIN ACTIVITIES:

### **Result 1 – Promote the competences of third social sector organizations that fight gender-based violence to access funding mechanisms from European funds.**

The related activities will be the distribution of 345,000 euros between 15 entities in the Spanish territory. The grants will range between 30,000 and 15,000 euros per project.

- **Call 1** - Services for victims or potential victims of GBV (psychological support, trauma-informed services, health care...)
- **Call 2** - GBV Multi Stakeholder coordination and capacity building of professionals and stakeholders involved in supporting gender violence victims (training, events, mutual learning activities...)
- **Call 3** - Actions to promote awareness among citizens, especially young people, at the local and national level through flashmobs, seminars, artistic performances, festivals and campaigns.
- **Call 4** - Research and political advocacy actions to improve knowledge and influence decision-making and improve laws (following the Istanbul Convention).

### **Result 2 – Increase opportunities for third social sector organisations at local, regional and national level in 3 European countries.**

The related activities are:

- Tutorials and assistance service for NGOs
- Monitoring of approved projects
- Online national training
- Exchange visits of national and EU networks

### **Result 3 – Strengthen networking and spaces for exchange between organizations of the third social sector in Italy, Spain and Greece.**

The related activities are:

- Online and face-to-face European meetings between organizations
- Joint communication campaign of the project
- Final event
